

## Centegra Health Bridge Fitness Center

### Facebook Contest Terms and Conditions – FEBRUARY/MARCH 2012

1. Participants will enter Centegra Health Bridge Fitness Center's (CHBFC) February/March Facebook Contest by posting a favorite Centegra Health Bridge class or program onto the Centegra Health Bridge Facebook "Wall".
2. Each NEW entry will enter the participant's name into the drawing. **Centegra Health Bridge Fitness Center is not responsible for Facebook, user account, personal or computer technical difficulties or malfunctions.**
3. All NEW posts must be posted on the CHBFC Facebook wall by Friday, March 23, 2012. One prize winner will be selected.
4. **Prize.** The prize is (4) 1-hour Fitness Coaching Sessions valued at \$280; which are not transferable, redeemable for cash or exchangeable for any other prize. The prize will be awarded to an eligible winner (see section 5). The prize must be claimed from the designated CHBFC Marketing Contact within thirty (30) days of the contest end date. If a winner cannot be contacted, or is disqualified for any reason, CHBFC reserves the right to designate an alternate winner, or not to award the original winner's prize, in its sole discretion.
5. **Eligibility and Limitations.** Participants and winner(s) must be U.S. residents at least 21 years of age. CHBFC reserves the right to refuse to award a prize to or on behalf of any minor. Only one (1) prize per household for the Contest. Only one (1) contest prize may be won per 12 month period, per household. Employees of Centegra Health Bridge, Centegra Health System, the Contest's participating sponsors and their advertising agencies, and their respective immediate family members are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.
6. **Publicity; Use of Personal Information.** By participating, where allowed by law, all participants and winner(s) grant CHBFC exclusive permission to use their names, characters, photographs, voices, videotape, and likenesses in connection with promotion of this and other contests and waive any claims to royalty, right, or remuneration for such use. By participating in the Contest, where allowed by law, participants agree that CHBFC may disclose personal information obtained from participants in the contest to third parties and use such information for marketing and other purposes.
7. **Release.** By participating in the Contest, each participant and winner waives any and all claims of liability against CHBFC, Centegra Health System, and their respective employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize.
